# <u>Inequalities in receipt of mental and physical healthcare in people with</u> dementia in the UK

Concludes that people with dementia, in particular women, appear to receive less primary healthcare, but take more psychotropic medication that may negatively impact their physical health.

Authors' conclusions: Included studies were heterogenous, recruited from specialist settings, and had potential biases. The studies identified did not allow specific recommendations to be made on the use of the IQCODE for the future diagnosis of dementia in clinical practice.

### Inhaler technique in children with asthma: a systematic review.

This systematic review examined: 1) the prevalence of correct inhaler technique among children with asthma, 2) if educational interventions are associated with improved rates of correct inhalation technique 3) is improved inhaler technique associated with improved asthma outcomes? ### Fibrates for primary prevention of cardiovascular disease events.

Jakob T. Cochrane Database of Systematic Reviews 2016;(11):CD009753.

Moderate-quality evidence suggests that fibrates lower the risk for cardiovascular and coronary events in primary prevention, but the absolute treatment effects in the primary prevention setting are modest (absolute risk reductions < 1%).

# <u>Diabetes (type 1 and type 2) in children and young people: diagnosis and management.</u>

In November 2016, recommendations 1.2.115 and 1.3.52 were amended to add information on when eye screening should begin and referral for eye screening should happen.

## Hypertension in adults: diagnosis and management.

In November 2016 a footnote about 2 MHRA drug safety alerts was added to recommendations in section 1.6 covering angiotensin-converting enzyme (ACE) inhibitors.

# Intermittent inhaled steroids reduce asthma attacks in wheezing preschool children

Regular daily steroid inhalers reduce the number of severe asthma exacerbations requiring soluble tablets or injections in wheezing preschool children by about a third.

## <u>Life-extending breast cancer drug approved by NICE in draft guidance</u>

People with advanced breast cancer are set to benefit from a life-extending drug as NICE says it should be available on the NHS.
