The brief nature of this group intervention means it may be particularly suitable for staff support and primary care mental health service settings. The findings indicate that the beneficial effects of an ACT workshop on distressed employees' mental health were linked to improvements in specific mindfulness skills.

NHS could save £81m a year though new tech designed to prevent strokes

More than 6,000 devices designed to prevent strokes are to be rolled out as part of a national campaign that could save the NHS £81 million a year. This includes <u>Kardia Mobile</u>, a small device that is able to detect irregular heart rhythms and the <u>Watch BP</u> blood pressure cuff, which can also detect heart rhythms.

NHS England has released a new digital roadmap that sets out its national objectives and timelines for the deployment of key national patient digital services and platforms, including the new NHS website and mobile app.

Efficacy of self-monitored blood pressure, with or without telemonitoring, for titration of antihypertensive medication (TASMINH4): an unmasked randomised controlled trial.

McManus, Richard J et al, The Lancet 10th March 2018; 391(10124): 949-959

Self-monitoring, with or without telemonitoring, when used by general practitioners to titrate antihypertensive medication in individuals with poorly controlled blood pressure, leads to significantly lower blood pressure than titration guided by clinic readings. This could become the cornerstone of hypertension management in primary care.

Patient contributions during primary care consultations for hypertension after self-reporting via a mobile phone self management support system.

Bengtsson, Ulrika et al, Scandinavian Journal of Primary Health Care; Mar 2018; 36 (1):70-79 Patients' contribution through interpretations of BP values to specific situations in their own lives brought on consultations where the patient as a person in context became salient. The mobile phonebased self-management support system can be used to support patient involvement in consultations with a person-centered approach in primary care hypertension management.
