There is a strong requirement for comparative studies to evaluate the effectiveness of different approaches to pain assessment and treatment among people with dementia in the community.

Early identification of memory changes in Alzheimer's disease is crucial to understanding changes that occur in the brain early in the disease process as well as to identifying treatments to help delay the onset of severe memory deficits. The findings of this review suggest that serial position effects represent one way in which researchers can identify subtle changes in memory functioning above and beyond more traditional memory scores.

The existing evidence supports the effectiveness of participatory horticultural therapy on cognitive function, agitation, positive emotion and engagement. Future high-quality original studies are needed to draw more robust conclusions.

This study aims to explore current practice regarding the annual dementia review in primary care by investigating: 1) what 'should' be happening in annual dementia reviews; 2) how dementia reviews are delivered in a sample of general practices; 3) the barriers and facilitators to the implementation of evidence-based care in dementia reviews; and 4) the experience of these reviews from the perspectives of people with dementia and their informal carer(s).

All GP practices provide surprisingly high continuity of care, albeit not with patients' assigned GPs. Patients are receiving continuity of care in relation to their condition.

# Preventative health screening community events, a mechanism to target minority ethnic populations in improving primary care utilisation to improve health outcomes

There was a significant benefit in providing community-based screening.There is a need for a longitudinal analysis to determine the impact on health outcomes and long-termaccess to healthcare provision.

### Adult patient perspectives on receiving hospital discharge letters: a corpus analysis of patient interviews

BMC health services research; Jun 2020; vol. 20 (no. 1); p. 537 Most patients value receiving copies of hospital discharge letters and should be consistently offered them. To enable positive outcomes letters should have a clear and accessible format that reflects the priorities and information needs of patients. Patients appear not to be receiving or being offered copies of letters consistently; this suggests a need for greater standardisation of practice.

### Applying critical systems thinking to social prescribing: a relational model of stakeholder "buy-in"

*Fixsen A. BMC health services research; Jun 2020; vol. 20 (no. 1); p. 580* Those implementing social prescribing in different localities inevitably face hard choices about what and whom to include. Research on the sustainability of social prescribing remains limited, studies are required to ascertain which "holistic" models of social prescribing work best for which communities, who are the main beneficiaries of these approaches and how "buy-in" is best sustained.

## How can referrals of patients who are obese to the local exercise referral scheme be increased? A UK based primary care quality improvement study

*Zaver V. et al.* The British journal of general practice Jun 2020; vol. 70 Interventions have increased the number of referrals to ERS and may be applied to similar primary care settings.

#### Weight assessment and the provision of weight management advice in primary care: a cross-sectional survey of self-reported practice among general practitioners and practice nurses in the United Kingdom

BMC family practice; Jun 2020; vol. 21 (no. 1); p. 111 Opportunities to provide weight management advice in primary care, including to patients with an obese BMI, are potentially missed. Future research should test alternative mechanisms to increase weight assessment and advice provision, examine the effectiveness of advice frequently given, and seek solutions to reported barriers for providing weight management advice.

#### Delays in referral from primary care worsen survival for patients with colorectal cancer: a retrospective cohort study

#### A simple test may predict the risk of hospitalisation for flare-up in patients with COPD.

NIHE Evidence.

The sit-to-stand test, which requires only a chair and a stopwatch, could identify patients with chronic obstructive pulmonary disease (COPD) who are at high risk of being admitted to hospital. Researchers found that the test, which takes less than five minutes to perform, also predicted the length of their hospital stay.

#### Disease self-management in patients with moderate COPD: a thematic analysis

Molin K.R. et al. European Clinical Respiratory Journal; Jan 2020; vol. 7 (no. 1) Patients with moderate COPD need more information, especially regarding the positive effects of physical activity. GPs might need to devote more time to the three main elements of COPD treatment, smoking cessation, medical treatment, and physical activity, to promote self-management and a healthier lifestyle in patients with COPD.

#### Smartphone Apps for Older Adults to Use While in Isolation During the COVID-**19 Pandemic.**

Banskota S.; Healy M.; Goldberg E.M.. Western Journal of Emergency Medicine 2020;21(3):514-525. Mobile technology could provide a valuable tool to help families stay connected, and to help older adults (OAs) maintain mobility and link them to resources that encourage physical and mental well-

### Development of the prototype concise safe systems checklist tool for general practice.

BMC health services research; Jun 2020; vol. 20 (no. 1); p. 544 As a result of this work the concise patient safety checklist tool, specifically designed for general practice, has now been made available as part of an online Patient Safety Toolkit hosted by the Royal College of General Practitioners. Senior practice staff such as practice managers and GP partners should find it a useful tool to understand the safety of less explored yet important safety processes within the practice.

## Interactive dashboard identifies patients at risk of unsafe prescribing in a flexible and sustainable way.

The Salford Medication Safety Dashboard (SMASH) was successfully used in general practices with the help of on-site pharmacists. SMASH is a web application that flags up a list of patients who are potentially at risk from medicines they have been prescribed

#### <u>A mixed methods analysis of lithium-related patient safety incidents in</u> primary care

Young R.S. et al.Therapeutic Advances in Drug Safety; 2020; vol. 11Despite the established link between medication packaging and the risk of dispensing errors, our study<br/>highlighted storage and packaging as the most commonly described contributory factors to dispensing<br/>errors. The absence of certain relevant data limited the ability to fully characterise a number of<br/>reports. This highlighted the need to include clear and complete information when submitting reports.



### Improving primary care identification of familial breast cancer risk using proactive invitation and decision support

Familial Cancer; 2020

This study demonstrated proactive risk assessment in primary care enables accurate identification of women, including many younger women, at increased risk of breast cancer. To improve generalisability across the population, more active methods of engagement need to be explored.

#### <u>Rheumatological conditions as risk factors for self-harm: A retrospective</u> cohort study

#### Arthritis care & research; Jun 2020

Primary care patients with fibromyalgia, osteoarthritis or rheumatoid arthritis (but not ankylosing spondylitis) are at increased risk of self-harm compared to people without these rheumatological conditions. Clinicians need to be aware of the potential for self-harm in patients with rheumatological conditions (particularly fibromyalgia), explore mood and risk with them, and offer appropriate support and management.

#### <u>Sharing reports about domestic violence and abuse with general practitioners:</u> a qualitative interview study.

Pitt, Katherine et al.BMC family practice; Jun 2020; vol. 21 (no. 1); p. 117GPs regarded external reports about DVA as relevant to their role, but safely recording thisinformation in the electronic medical record and using it to support patients required complexjudgements. Both GPs and police staff emphasised the importance of clarity of information andresponsibility for action when information was shared between agencies about patients affected byDVA.
