Request for Information: Freedom of Information Act

Thank you for your email of 22 June, making a request for information under the Freedom of Information Act. You requested the following information and the Trust is able to provide the information below in response:

Request:

- 1, Does your organisation contribute to Multi Agency Safeguarding Hub (MASH) arrangements within your local area?
- 2, Where there are multiple MASH arrangements within the geographical area that your organisation covers does your organisation contribute to all MASHs?
- 3, How many staff does your organisation employ within your Trust Safeguarding Team?
- 4, What are the job titles of all staff within the Trust Safeguarding Team?
- 5, What are the pay grades of all the staff within the Trust Safeguarding Team?

Response:

- 1. Adult Safeguarding: OHFT is a "virtual" partner in the MASH for adults in Buckinghamshire that is a designated member of staff will be contacted by the MASH when information is required. From May 2018, we have just started to co-locate one member of staff in the MASH but their role is intermittent and is not currently covered. There is no MASH for adults in Oxfordshire.
- 2. OHFT only contributes to the MASH in Buckinghamshire see above.
- 3. There are two full time members of staff in the Safeguarding Adults Team. A part-time member of staff will be starting in July.
- 4. Safeguarding Adults Manager. Safeguarding Adults Practitioner

5. Band 8b and band 7

Children and Young People Safeguarding.

1. Yes the safeguarding children team sit in the MASH 3 days in Oxfordshire and virtual partners 5 days in Buckinghamshire.

Oxford Health provides CAMHs mental health input in to the MASH in Buckinghamshire and Wiltshire.

- 2. In Swindon Wiltshire and Bath and North East Somerset areas, we only have formal arrangements in Wiltshire. Staff directly working with the child are contacted on a case by case basis.
- 3. WTE: 8.1 full time equivalent named nurses/professional

1 sessions a week trust lead doctor

1 session a week named doctor

1.2 safeguarding administrator

(In total 14 people including 9 nurses, 2 doctors, 1 named professional, 2 administrators)

within 40 working days of the date the response is received by the applicant, and will apply discretion if a longer period of time has passed.

Should you wish to make a complaint as a result of the outcome of such a review, you may apply directly to the Information Commissioner's Office (ICO) for a decision.

Generally, the ICO cannot make a decision unless you have exhausted the complaints procedure provided by the Trust for Fol Act matters.
