### **Training**

How often do you undertake any education or training around safeguarding guidance? All clinical staff are required to undertake safeguarding training once every three years as a minimum.

**Updating and Dissemination** 

How often are safeguarding guidance standards updated? As changes occur and to reflect any changes from the safeguarding adults boards.

# Storage and accessibility

In what format and programme do you hold your safeguarding guidance? Policy is held on the Trust intranet as a PDF document. LSAB guidance is on the internet webpage. There is a safeguarding adults intranet webpage.

In what format and programme do staff access this guidance? Via the Trust intranet and the LSAB internet webpages.

Can you access safeguarding guidance on mobile devices? Staff can access the internet and intranet via Trust iPads and computers.

If so, can this guidance be accessed while offline? People can print off hard copies of the guidance. If additional advice is required there is a telephone consultation process in place during week day working hours and an on-call manager outside of these times.

#### Quantitative measures

The Trust will consider undertaking a review if requested to do so within 40 working days of the date the response is received by the applicant, and will apply discretion if a longer period of time has passed.

Should you wish to make a complaint as a result of the outcome of such a review, you may apply directly to the Information Commissioner's Office (ICO) for a decision.

Generally, the ICO cannot make a decision unless you have exhausted the complaints procedure provided by the Trust for Fol Act matters.
