Thank you for your email of 8 September making a request for information under the Freedom of Information Act. You requested the following information and the Trust is able to provide the information below in response:

I am undertaking research and I was hoping to get data for a 12 month period between 2016/2017, pertaining to adult inpatient mental health facilities, including:

- 1. number of admissions (formal and informal) to psychiatric facilities;
- 2. number of restraints;
- 3. number of restraints per 100 admissions per month;
- 4. patients affected by restraint per 100 admissions per month;
- 5. events per 100 occupied bed days per month;
- 6. events per 100,000 population per year;
- 7. patients affected by restraint per 100 occupied bed days per month;
- 8. average number of restraints per affected patients
- 9. percentage of patients exposed to restraint and seclusion
