What was the cost of out-of-area inpatient placements for your trust's children and young mental health patients in: 2014/2015, 2015/2016, 2016/2017, 2017/2018 and so far in 2018/2019?

How many inpatient placements for adult mental health patients in Oxfordshire were there in: 2014/2015, 2015/2016, 2016/2017, 2017/2018 and so far in 2018/2019?
